2. Scrutiny of Nominations & Publication of List	4 th Nov, 2019 (5 PM)
3. Last Date of Withdrawal of Nomination	7 th Nov, 2019 (5 PM)
4. Publication of Final List of Valid Candidates	12 th Nov,2019 (9 PM)
5. If Voting Required Date Schedule to be Floated	20 th Nov 2019

*If sufficient nominations are not received for any post, it shall be discussed in the chapter EB meeting at the Pedicon at Indore and then ratified later at the CNDP Annual General Body Meeting to be scheduled at the Pedicon in Indore on 9th-12th January 2020 and a candidate will be selected from interested persons for the vacant posts .

*In case there are multiple contestants for any post, voting will be done by Ballot/E-voting - schedule for which plan will be declared after 20th Nov 2019 .

In case any member has any complaint about the election, he /she shall give the same in writing addressed to the Chairperson of the Chapter of Neuro Developmental Pediatrics IAP within 21 days of the declaration of the result. An Election Tribunal consisting of the Chairperson of CNDP as the Chairperson and two Immediate Past chairpersons in order shall be constituted to go into the complaint and the decision of the Tribunal shall be final if there is a difference among the members of the election tribunal, the decision shall be by majority. A member complaining against the election process/commission will abide by the final decision of the tribunal.
